### First level Teaching Courses

Digital and Organisational Innovation	It is a 48-hr course available to students at the 2nd-year from more master programmes at LUISS University. By using scientific papers and cases analysis, and varying the perspective from technology to individual and organization, the goals are those of soliciting reflections and generating knowledge on the transformation that digitization and the new technologies - e.g., platforms, blockchain, AI, IoT, big data ... - bring into organizations. The course involves also the experience on methods - e.g., design thinking, visualization, journey map - that fit better digital innovation process, and a group project work to deepen the analysis on a real innovation
Digital Entrepreneurship Lab	32-hr course for students at the last year of the undergraduate programme in Computer Science at LUISS University. By adopting the Design thinking approach and methods, this laboratory leads students along all steps of an innovation process, from users' profiles and needs identification, to ideation, prototyping, business model, final pitch
Turning Data into Knowledge	Undergraduate course (42 hrs.) offered by the Department of Management Information Systems, Temple University. This course teaches about good visualizations to effectively communicate a message, from identifying the context of the data, selecting appropriate data and visualization techniques to extract information and maximize efficacy, to making compelling recommendations through a story with data. It is fully based on hands-on practices, using advanced tools
Data Science	Undergraduate course (42 hrs.) offered by the Department of Management Information Systems, Temple University. The aim is that of introducing students to the main aspects and issues related to data: sources, structuring, cleaning, quality, merging/matching, inquiry building, data visualization, misuses. It is also based on a large use of in-class activities and homeworks to let students making experience on operating on, inquiring and visualizing data
Information Systems Organization	Course available at the second-last year of the master degree programme in Business Management. The course (initially 60, then 45 hrs.) aims at providing students the knowledge about the management of the resource information by means of digital technologies for organizations of any kind. Topics include fundamental concepts – data and information definition, Information System, process ... –, and all the phases of IS development and management, ranging from the feasibility study up to implementation and use
Information Systems in Organizations	Undergraduate course (36 hrs.) offered by the Department of Management Information Systems, Temple University. The aim is that of introducing the fundamentals of Information Systems in the perspective of business organizations, together with the basic elements for Javascript coding
Human Resource Management	Course offered to students at last year of the undergraduate programme in Political Science at University of Tuscia (initially 60, then 48 hrs.). After an alignment on Organization Theory main concepts, the course deals with all the topics of HRM, examined under both the perspectives of 'traditional' theories and of consequences of digital transformation on work and workplace. To link the course to changing reality, classes make large recourse to case studies and discussions and a group project work on a real organization is carried on.
Organization Theory	Course offered by the Department of Economics and Management, University of Tuscia at the last year of undergraduate programme in Business Management. It is a 48-hour course, whose aim is that of making students acquainted of the fundamentals of organization theory: design of structures, control mechanisms and culture, change management, decision theory. By making use of readings, case studies, discussions and a group project work on a real organization of any size and nature, the course proposes continuously bridges between theories and reality.
Organization Theory	Course offered at the Faculty of Social Sciences at the last year of the undergraduate programme in Sociology. . It is a 40-hour course, with the aim of making students of sociology acquainted of the fundamentals of organization theory and how organization work. Through case studies, discussions and a group project work, the students explore the management side of organizational social phenomena

Tommaso Federici has always been fascinated by the innovation process, particularly when a new IT artifact is introduced into an organization, possibly supported by a new organization design. Such innovation might (or may not) generate impacts, either positive or negative, on cultures, persons, habits, structures and performance. This is a frontier territory, possibly to be understood according to multiple perspectives. Hence, Tommaso always tried to follow a multi-disciplinary approach, joining the scholars' and the practitioners' perspectives, and trying to match theoretical rigour with practical relevance.
