Cracking the Stone: This research originates from several questions at the intersection of memory, urban and migration studies, such as what is the place of migration memory in urban spaces? How do the variety of collective memories intersect and shape local governance? Who are the main memory actors contributing to local governance? Is there a politics of migration memory in the city? Does it affect state's policies?

In November 2023 Italy signed an agreement with Albania to examine asylum requests in two centres built in Albanian territory. Once a colony of the Italian fascist empire, Albania is the origin of migrants arriving in Italy today together with many others who, from the former Italian East Africa, travel through the hell of Libya, a former colony itself, where detention camps for migrants today insist on former fascist prisons where the local population was deported and starved to death. The memory of the atrocities committed during the Italian colonial period have been carefully removed and replaced by the myth of *italiani brava gente*, an insidiously solemn tale that portrays Italians as an innocuous and benign presence in colonies. Central to this research is the reflection on how the lack of

memory debate over the horrors committed during the Italian colonial rule has been transposed on urban markers of Rome, and ultimately how this attitude has converted in an apathetic general attitude toward contemporary policies of migration control.

2023

The Tiber Project

A multidisciplinary project with the aim is to re-discover a new significant role for the river in the life of the city through a plurality of actions.

- Improve the quality of the environment, through the recovery of the ecological qualities lost by this ecosystem;
- Increase the connections between the city and the river and, when is possible, create and discover a sequence of public spaces and public routes that will create a network of public life;
- Encourage ecologically sustainable movement, with the rediscovery of a new pedestrian and bicycle network, as well as the navigation of the river itself;
- Propose the re-qualification of historical and archaeological resources, a patrimony of episodes that represent the thousand years of history of the city.

2022 -2024

Red Door. This research project build on my research on citizenship acquisition and national dynamics in Italy with a special focus to those born by migrant parents. I discuss it by going back to the tragic fate of Saman Abbas, a young Pakistani girl who was killed in 2021 by her family in the countryside of Reggio Emilia because she had refused to give herself in an arranged marriage with her cousin. The research has begun with few ethnographic visits in the Parma area to analyze the dynamics of isolation of migrant communities involved in the core of the multimillion agri-food Italian industry and the marginalization of those young generations who dwell within. I asked how the racialization of different migrant communities play a role in the functioning of the agribusiness of the area. I then have proceeded with a historical and legal excursus on Italian migration and related citizenship laws to argue for the central role of citizenship acquisition as a tool for integration.

2018-2024

Foreignness, Forensis, and Redemption. This project builds on earlier collaborative work on affective economies, visual anthropology, urban meta-logistics with attention to monuments, architecture, artifacts, and city-camps in Kenya. For the earlier project, I have already published two essays titled 'Between Camps / Between Cities: Movement, Capture, and Insurrectional Migrant Lives published in *Globalizations Journal* (special issue on Insurrectional Politics edited by Nevzat Soguk). The second article is titled "Affective Economies: Eastleigh's Meta-logistics, Urban Anxieties and the Mapping of Diasporic City Space" (published in *African Identities*). For the current project, (in line with my ongoing research and teaching on *Spaces of Exception* and precarious lives of African Migrants in Europe and elsewhere) I focus on the dynamics of abandonment, survival, and redemption in Ballaro Market in Palermo and carried out initial fieldwork in November 2017(supported by Vassar College's Fall 2017 Research Committee Award).

2021-2022

Essere Fiume

The overall project I have co-envisioned around Rome's Tiber was implemented by a group of professional archaeologists and theatre artists together with marginalized individuals (elders, disabled, refugees, migrants, US students abroad). It included both long walks and innovative theatrical activities in key historical sites along the river that traverses the city. The immediate scope was to create a dialogue between marginalized communities and the archaeological heritage of Rome normally precluded to those subjects, via artistic methodologies – namely visual art and theatre, to reclaim that space and the authority of knowledge in connection with it. The project was part of 'Co-creating Intercultural Societies: a Focus on Racism and Discrimination' - DRIS is funded by the European Union's 2014-2020 Creative Europe Programme. It emerges from the observation that different and effective initiatives, albeit isolated, exist but at an initial or pilot stage. The project aimed to enhance respect and mutual understanding for cultural diversity through intercultural dialogue and to facilitate cultural participation of migrant communities, by developing effective counter-narratives through art and culture, especially among multi-ethnic and multicultural communities in Rome.

Interrupted Flows

Multimedia Research project with the help of the Temple's Presidential Humanities and Arts Awards which includes curating a photo exhibition and a book. The project through images of and by migrants, aims at "new politics of truth" underlying the migrant's journey from Africa to settlement in Europe, and sometimes back again. This interdisciplinary project impels the audience to see the migrant's experience as their own, and to engage in a different internal and external discourse about the politics of migration within our postcolonial reality.
